

The Holocaust

Nowadays the Holocaust is an expropriated category which has become the symbol of all the world’s crimes against the Jews as well as of everybody’s indelible and undisputed guilt before the one and only “god’s [minuscule g in the text] chosen people.” In some countries it is even forbidden to doubt, research or correct the number of victims. And there are things to correct. For example, when we look into the ethnicity of the Nazis’ 18 million victims, we find that 6 million were Jews and 12 million belonged to other nations. But that a third of the genocide has to do with Jews dominates, and is reaching the level of the absurd, and becomes part of a profitable industry. Meanwhile, two thirds of “goys” remain not important, dead and unknown.

Nevertheless it is much more important that the Holocaust has become a dogma that supports the political and class interests of the Jews.

The role of the World’s Victim is a counterweight to Israel’s responsibility for one million refugees and its aggression against neighboring countries. At the same time 300,000 Holocaust victims who survived live very poorly in the “promised land,” although from Switzerland alone, the Zionists have robbed billions in the name of the victims. Not to mention the German payments.

So about 12 million victims of the Holocaust who were of other nationalities remain unknown to the world, insignificant and forgotten. Apart from the Nazi genocide, there is the Soviet genocide, that destroyed whole nation. In the USSR alone, some 90 to 100 million civilian inhabitants were killed; in China – 45 million; in Cambodia – 3 million, etc. If we add up all the people who died because of the “ghost of socialism” in the course of the 20th century, we get 200 million! That is without the 72 million victims of Chernobyl.

These numbers, that are hard to grasp, are the result of a policy that sought to eliminate people, and everybody is being blamed for it, except the real perpetrators. And it is precisely their unmasking before the public and this evaluation that are important for the future, for guilt and reparations as well as for the prevention of future crimes.

The witch-hunt for Jew-shooters [sg. “žydšaudžys“, untranslatable with all its connotations] had to cover for, and finally did cover for, the main planners and perpetrators of the “final solution of the Jewish problem,” in other words, the main criminals. But people’s memory lives on and is being transmitted from generation to generation. For example, M. Gilbert’s world famous book “Never Again” seeks precisely this goal – to find the real perpetrators, name them and evaluate their actions so that it would not happen again!

Have you ever heard that the list of 11 million Jews that were condemned to death was compiled by a 100% Jew, Adolf Eichmann, who was born in Israel in 1906? Have you ever heard that this list was discussed and

approved by 13 (!?) members of Hitler's gang – all, according to Klimov, 100% Jews, except for the Fuehrer himself who only had a Jewish grandfather?

No, you haven't read or heard about it. The world hears only the names of the Ukrainian Demjanjuk (later acquitted) or the Lithuanians A. Lileikis and M. Dailidė. But not the name of A. Eichmann, although he was condemned to death for it. But not the names of Heydrich, of Muller, of Himmler, Bormann, Hess... Neither world Jewry, nor Israel publicizes the nationality of the authors of "the final solution of the Jewish question" or the heads of the institutions (SS, Gestapo) that implemented it. Thus the Zionists, who inspired such a policy, and their goals, to cause Jewish refugees and direct them towards Palestine where the state of Israel would be created, remain in the shadows.

The goal has been achieved. For the price of 6 million Jewish lives the State of Israel was established and populated with Jews who ran away from death. Now the second goal is being reached – to blame others for one's own sins and to obtain reparations. Successfully, it seems!

By the way, both the USA and the USSR helped to implement this plan, because they refused entrance for refugees and directed the flow according to the Zionists' wishes. The cruelest case in the USA was that of the ship "St Louis" which carried Jewish children and was not allowed into any American port and had to sail back to Europe where it was threatened by the Nazis. The children were saved by Scandinavians.

The USSR closed the border for Jews as well.

So the Jews were being saved by European nations that risked their lives. And now they are being accused of Jew-shooting, although the occupiers did it. As the saying goes, the lamb is already guilty because the wolf is hungry. The same with the Holocaust – the rescuers of Jews were an obstacle to the Zionists who wanted to populate Palestine and create their state there. Nowadays the flow of emigrants from Israel that amounts to hundreds of thousands and is much bigger than the number of those who arrive in the country, proves that if not for the Holocaust, Jews would not have gone to Palestine. And certainly they would not have become cannon fodder in never ending wars with neighboring states. They lived perfectly well in different countries and did not long for the Arabs' deserts. So it was necessary to make the conditions unbearable for Jews. And the Holocaust suited this purpose...

The planners and organizers of Soviet genocide are, alas, also Jews. Starting with Trotsky (Bronstein), who promised to make the world get on its knees and strangle it in slavery, Lenin (who's mother was Miriam Abelevitch Blank), Putin (Solomon) and not finishing with Medvedev (David Aaronovitch Mendel). And what is there to say about the crystal-clear conscience of Dzerzhinsky, Kaganovich, Beria or Nachman Dushansky? They all are biblical brothers, except Stalin who only had a Jewish grandfather.

Both Soviet and Nazi genocide planners murdered not only Jews, but other nationalities as well, just that the relative numbers are different. What is more, the Soviets have not been completely unmasked in public. The condemnation of communism that had started in the EU should result in desovietization, the same as denazification in Germany. But the immense

territory of the former USSR with masses of inhabitants still supplies Israel with a small flow of Jews that arrive to the country, so the Zionists do not publicize the Soviet genocide and certainly do not ask for reparations...

Two gangs of petty politicians – those of Hitler and Stalin – both composed of Jewish members, both based on the ideology of socialism (one on the Nazi, another on the communist trend), the father of which also was a Jew, K. Marx (Mordechai Levi), perpetrated the genocide of 200 million civilian inhabitants, unseen in the world's history, so they should be treated equally as having committed crimes against humanity and against their own Jewish nation. Most importantly, they both must be banned, and the guilty ones that remain alive must be punished.

Meanwhile such a decision is implemented only in the case of Nazis and communists are still not being put to judgment. And those who inspired the crimes, the Zionists, are not even mentioned. Only N. Finkelstein showed the real predatory face of international Zionism in his book "The Holocaust Industry." And they, the Zionists, are now implementing the second part of their plan – seeking reparations from nations and states for their own personal crimes!

It is most interesting and painful, that reparations are only given to Jewish victims of the Holocaust! And other nations stay without compensation although they are twice as numerous as the Jews! The disabled, communists, socialists, ethnic groups such as Gypsies, Poles, Belarusians also suffered from the Nazis. But only Jews will get the money, if they live to see it. And there is no haste. This is where our V. Blinkevičiūtė [minister of Social Affairs and Labor] learns how not to give pensions to the retired!...

To speak about Lithuania, the Nazis here killed 170,000 Lithuanians and 130,000 Jews. But nobody, except historians, speaks about Lithuanian victims, while the number of Lithuanian Jews killed is being publicized all the time and has now reached the limit of 200,000. Eichmann's list states the number of Jews that ought to be liquidated in Lithuania as 34,000. According to the census, there were 130,000 of them in Lithuania. But at the Munich summit the Jews already found 160,000 and presented this number to the Nuremberg Tribunal. Maybe it is together with 30,000 Jewish refugees from Poland. On this point it is possible to agree. But today they already speak about 210,000 Litvaks who were almost entirely wiped out! And without citing the sources. Meanwhile, historian A. Eidintas states in his book that 56,000 Jews (30% of 160,000 or 2% [printing error] of 210,000) managed to survive and even points out how many of them were evacuated and to where!!!

We can establish that the Jews are involved in a clear fabrication of numbers. And this is the case with the whole research of the Holocaust. And not only do they cheat, but Lithuanians are being blamed for their death as well! The Holocaust was planned by the Jew A. Eichmann, approved by Hitler's Jewish gang, and implemented by the German SS and Gestapo, but nobody called Germans Jew-shooters! Maybe because Germany, under no-one's pressure, paid out 60 billion US dollars for Jewish investments?

Let's say that after the USA's war in Indochina that industry and agriculture were destroyed as well, but President Carter refused to pay

reparations to the Vietnamese, with the motivating argument that the destruction was mutual! He forgot that the USA attacked and that Vietnam defended itself? But Jewish standards are not applied to goys. Thanks to the Holocaust, Jews acquire historic privileges worldwide.

Besides the economic benefits from the Holocaust, the Zionists also get significant political dividends: escalation of hatred towards Jews, a moral premise for political pressure when defending Jewish interests that are sometimes unlawful.

This is the case of Jewish property in Lithuania that has been allocated to the synagogues, although Article 29 of the Lithuanian Constitution does not allow any privileges on any basis – even religion. Or, the pretext of a purportedly Jewish cemetery (in fact, only a piece of land being marked and sold), which caused an international scandal about Jews who again became victims. Meanwhile, Guggenheim-Ermitazh was silently given a building plot, together with half a billion extra from our, the taxpayers' pocket. And the scandal quieted down.

But the Holocaust industry serves most successfully to strengthen Israel's status as a country of "victims" and to eliminate any criticism or responsibility for neighboring countries' aggressiveness. After all, hardly anybody knows how many hundreds of severe notices the United Nations presented to Israel because of breaches of international law. There are several hundred of them and behind them all lies people's blood, houses, and motherland. And it means precisely nothing to Israel! But it is enough for some brat to say "Children, take a stick and hit that little Jew" [reference to a rhyme chanted in the March 11 Neo-Nazi parade on Gedimino Boulevard in Vilnius, where the version used had "kill that little Jew"] in a counting game; but Israel Knesset's representative breaches protocol and norms of behavior that apply for guests, and any kind of decency, in the Lithuanian Seimas. No representatives of any nations behave like that. Only Jews.

So, isn't it true that the Holocaust industry contributes to the instigation of Antisemitism and to the tensions between nationalities? In a word, one beats oneself and then shouts too [proverb].
